### **Blue Whale Finance Terms & Conditions**

These Blue Whale Finance Terms of Use is entered into between you (hereinafter referred to as "you" or "your") and Blue Whale Finance operators (as defined below). By accessing, downloading, using or clicking on "I agree" to accept any Blue Whale Finance Services (as defined below) provided by Blue Whale Finance (as defined below), you agree that you have read, understood and accepted all of the terms and conditions stipulated in these Terms of Use (hereinafter referred to as "these Terms") as well as our Privacy Policy at www.BlueWhaleFinance.io and our App In addition, when using some features of the Services, you may be subject to specific additional terms and conditions applicable to those features.

Please read the terms carefully as they govern your use of Blue Whale Finance Services. THESE TERMS CONTAIN IMPORTANT PROVISIONS INCLUDING AN ARBITRATION PROVISION THAT REQUIRES ALL CLAIMS TO BE RESOLVED BY WAY OF LEGALLY BINDING ARBITRATION. The terms of the arbitration provision are set forth in Article 10, "Resolving Disputes: Forum, Arbitration, Class Action Waiver", hereunder. As with any asset, the values of Digital Currencies (as defined below) may fluctuate significantly and there is a substantial risk of economic losses when purchasing, selling, holding or investing in Digital Currencies and their derivatives. BY MAKING USE OF BLUE WHALE FINANCE SERVICES, YOU ACKNOWLEDGE AND AGREE THAT: (1) YOU ARE AWARE OF THE RISKS ASSOCIATED WITH TRANSACTIONS OF DIGITAL CURRENCIES AND THEIR DERIVATIVES; (2) YOU SHALL ASSUME ALL RISKS RELATED TO THE USE OF BLUE WHALE FINANCE SERVICES AND TRANSACTIONS OF DIGITAL CURRENCIES AND THEIR DERIVATIVES; AND (3) BLUE WHALE FINANCE SHALL NOT BE LIABLE FOR ANY SUCH RISKS OR ADVERSE OUTCOMES.

By accessing, using or attempting to use Blue Whale Finance Services in any capacity, you acknowledge that you accept and agree to be bound by these Terms. If you do not agree, do not access Blue Whale Finance or utilize Blue Whale Finance services.

## I. Definitions

- 1. Blue Whale Finance refers to an ecosystem comprising Blue Whale Finance websites (whose domain names include but are not limited to https://www.Blue Whale Finance.io), mobile applications, clients, applets and other applications that are developed to offer Blue Whale Finance Services, and includes independently-operated platforms, websites and clients within the ecosystem (e.g. Blue Whale Finance's Open Platform, Blue Whale Finance MoneyEX, Blue Whale Finance Labs, Blue Whale Finance Charity, Blue Whale Finance DEX, Crypto Wallet, and fiat gateways). In case of any inconsistency between the relevant terms of use of the above platforms and the contents of these Terms, the respective applicable terms of such platforms shall prevail.
- 2. Blue Whale Finance Accounts refer to the foundational virtual accounts, including main accounts and subaccounts, which Blue Whale Finance opens for Users to record on Blue Whale Finance their usage of Blue Whale Finance Services, transactions, asset changes and basic information. Blue Whale Finance Accounts serve as the basis for Users to enjoy and exercise their rights on Blue Whale Finance.
- 3. Blue Whale Finance Fiat Account means the record of your fiat currencies' balance (if any), which is enabled through an electronic money wallet (or similar account) service that is provided by a Fiat Partner.
- 4. Blue Whale Finance Operators refer to all parties that run Blue Whale Finance, including but not limited to legal persons, unincorporated organizations and teams that provide Blue Whale Finance Services and are responsible for such services. For convenience, unless otherwise stated, references to "Blue Whale Finance" and "we" in these Terms specifically mean Blue Whale Finance Operators. UNDER THESE TERMS, BLUE WHALE FINANCE OPERATORS MAY CHANGE AS BLUE WHALE FINANCE'S BUSINESS ADJUSTS, IN WHICH CASE, THE CHANGED OPERATORS SHALL PERFORM THEIR OBLIGATIONS UNDER THESE TERMS WITH YOU AND PROVIDE SERVICES TO YOU, AND SUCH CHANGE DOES NOT AFFECT YOUR RIGHTS AND INTERESTS UNDER THESE TERMS.ADDITIONALLY, THE SCOPE OF BLUE WHALE FINANCE OPERATORS MAY BE EXPANDED DUE TO THE PROVISION OF NEW BLUE WHALE FINANCE SERVICES, IN WHICH CASE, IF YOU CONTINUE TO USE BLUE WHALE FINANCE SERVICES, IT IS DEEMED THAT YOU HAVE AGREED TO JOINTLY EXECUTE THESE TERMS WITH THE NEWLY ADDED BLUE WHALE FINANCE OPERATORS. IN CASE OF A DISPUTE, YOU SHALL DETERMINE THE ENTITIES BY WHICH THESE TERMS ARE PERFORMED WITH YOU AND THE COUNTERPARTIES OF THE DISPUTE, DEPENDING ON THE SPECIFIC SERVICES YOU USE AND THE

### PARTICULAR ACTIONS THAT AFFECT YOUR RIGHTS OR INTERESTS.

- 5. Blue Whale Finance Services refer to various services provided to you by Blue Whale Finance that are based on Internet and/or blockchain technologies and offered via Blue Whale Finance websites, mobile applications, clients and other forms (including new ones enabled by future technological development). Blue Whale Finance Services include but are not limited to such Blue Whale Finance ecosystem components as Digital Asset Trading Platforms, the financing sector, Blue Whale Finance MoneyEX, Blue Whale Finance Charity, Blue Whale Finance Info, Blue Whale Finance Launchpad, Blue Whale Finance Research, Blue Whale Chain,
- 6. Blue Whale Finance Platform Rules refer to all rules, interpretations, announcements, statements, letters of consent and other contents that have been and will be subsequently released by Blue Whale Finance, as well as all regulations, implementation rules, product process descriptions, and announcements published in the Help Center or within products or service processes.
- 7. Collateral Accounts refer to special accounts opened by Users on Blue Whale Finance to deposit and withdraw collateral (such as margins) in accordance with these Terms (including the Blue Whale Finance Contract Services Agreement and Blue Whale Finance Platform Rules), as required for contract transactions, leveraged trading and/or currency borrowing services.
- 9. Designated Stablecoin means each of USD Coin (USDC), Pax Dollar (USDP), TrueUSD (TUSD) and any other Digital Asset Blue Whale Finance may designate as such from time to time, provided that Blue Whale Finance may remove any Digital Asset from the scope of this definition at any time without prior notice.
- 10. Designated Stablecoin Conversion means, in respect of each Designated Stablecoin, the automatic conversion of that Designated Stablecoin into BUSD upon deposit or transfer into your Blue Whale Finance Account or the conversion of BUSD into that Designated Stablecoin in connection with a withdrawal request.
- 11. Digital Currencies refer to encrypted or digital tokens or cryptocurrencies with a certain value that are based on blockchain and cryptography technologies and are issued and managed in a decentralized form.
- 12. Digital Assets refer to Digital Currencies, their derivatives or other types of digitalized assets with a certain value.
- 13.Loan/Lending refers to Blue Whale Finance's lending of Digital Currencies to Users at an interest collected in certain ways (in the form of Digital Currencies), including but not limited to the leveraged trading and currency lending services currently offered, and other forms of loan/lending services to be launched by Blue Whale Finance.
- 14. Spot Trading means buying or selling supported Digital Assets and/or any supported fiat currency on the exchange for immediate settlement.
- 15. Users refer to all individuals, institutions or organizations that access, download or use Blue Whale Finance or Blue Whale Finance Services and who meet the criteria and conditions stipulated by Blue Whale Finance. If there exist other agreements for such entities as developers, distributors, market makers, and Digital Currencies exchanges, such agreements shall be followed.

## **II. General Provisions**

1. About These Terms

### a. Contractual Relationship

These Terms constitute a legal agreement and create a binding contract between you and Blue Whale Finance Operators.

### b. Supplementary Terms

Due to the rapid development of Digital Currencies and Blue Whale Finance, these Terms between you and Blue Whale Finance Operators do not enumerate or cover all rights and obligations of each party, and do not guarantee full alignment with needs arising from future development. Therefore, THE PRIVACY POLICY ( () ), BLUE WHALE FINANCE PLATFORM RULES, AND ALL OTHER AGREEMENTS ENTERED INTO SEPARATELY BETWEEN YOU AND BLUE WHALE FINANCE ARE DEEMED SUPPLEMENTARY TERMS THAT ARE AN INTEGRAL PART OF THESE TERMS AND SHALL HAVE THE SAME LEGAL EFFECT. YOUR USE OF BLUE WHALE FINANCE SERVICES IS DEEMED YOUR ACCEPTANCE OF THE ABOVE SUPPLEMENTARY TERMS.

## c. Changes to These Terms

Blue Whale Finance reserves the right to change or modify these Terms in its discretion at any time. Blue Whale Finance will notify such changes by updating the terms on its website () and modifying the [Last revised] date displayed on this page. ANY AND ALL MODIFICATIONS OR CHANGES TO THESE TERMS WILL BECOME EFFECTIVE UPON PUBLICATION ON THE WEBSITE OR RELEASE TO USERS. THEREFORE, YOUR CONTINUED USE OF BLUE WHALE FINANCE SERVICES IS DEEMED YOUR ACCEPTANCE OF THE MODIFIED AGREEMENT AND RULES. IF YOU DO NOT AGREE TO ANY CHANGES TO THESE TERMS, YOU MUST STOP USING BLUE WHALE FINANCE SERVICES IMMEDIATELY. ## d. Prohibition of Use

BLUE WHALE FINANCE RESERVES THE RIGHT TO CHOOSE MARKETS AND JURISDICTIONS TO CONDUCT BUSINESS, AND MAY RESTRICT OR REFUSE, IN ITS DISCRETION, THE PROVISION OF BLUE WHALE FINANCE SERVICES IN CERTAIN COUNTRIES OR REGIONS.

## 2. About Blue Whale Finance

As an important part of the Blue Whale Finance Ecosystem, Blue Whale Finance mainly serves as a global online platform for Digital Assets trading, and provides Users with a trading platform, financing services, technical services and other Digital Assets-related services. As further detailed in Article 3 below, Users must register and open an account with Blue Whale Finance, and deposit Digital Assets into their account prior to trading. Users may, subject to the restrictions set forth in these Terms, apply for the withdrawal of Digital Assets.

Although Blue Whale Finance has been committed to maintaining the accuracy of the information provided through Blue Whale Finance Services, Blue Whale Finance cannot and does not guarantee its accuracy, applicability, reliability, integrity, performance or appropriateness, nor shall Blue Whale Finance be liable for any loss or damage that may be caused directly or indirectly by your use of these contents. The information about Blue Whale Finance Services may change without notice, and the main purpose of providing such information is to help Users make independent decisions. Blue Whale Finance does not provide investment or consulting advice of any kind, and is not responsible for the use or interpretation of information on Blue Whale Finance or any other communication medium. All Users of Blue Whale Finance Services must understand the risks involved in Digital Assets trading, and are recommended to exercise prudence and trade responsibly within their own capabilities.

- 3. Blue Whale Finance Account Registration and Requirements
- a. Registration

All Users must apply for a Blue Whale Finance Account at (https://BlueWhaleFinance.io) before using Blue Whale Finance Services. When you register a Blue Whale Finance Account, you must provide the information identified in this paragraph 3 or otherwise as requested by Blue Whale Finance, and accept these Terms, the Privacy Policy, and other Blue Whale Finance Platform Rules. Blue Whale Finance may refuse, in its discretion, to open a Blue Whale Finance Account for you. You agree to provide complete and accurate information when opening a Blue Whale Finance Account, and agree to timely update any information you provide to Blue Whale Finance to maintain the integrity and accuracy of the information. Each User (including natural person, business or legal entity) may maintain only one main account at any given time. However, Users can open one or more subaccounts under the main account with the consent of Blue Whale Finance. For certain Blue Whale Finance Services, you may be required to set up a specific account independent from your Blue Whale Finance Account, based on the provisions of these Terms or the Supplementary Terms. The registration, use, protection and management of such trading accounts are equally governed by the provisions of this Section and Section VI, unless otherwise stated in these Terms or the Supplementary Terms.

# b. Eligibility

By registering to use a Blue Whale Finance Account, you represent and warrant that: (i) as an individual, you are at least 18 or are of legal age to form a binding contract under applicable laws; (ii) as an individual, legal person, or other organization, you have full legal capacity and sufficient authorizations to enter into these Terms; (iii) you have not been previously suspended or removed from using the Blue Whale Finance Platform or the Blue Whale Finance Services; (iv) you do not have an existing Blue Whale Finance Account; (v) you are not resident, located in or otherwise attempting to access the Blue Whale Finance Platform or the Blue Whale Finance Services from, or otherwise acting on behalf of a person or legal entity that is resident or located in, a Restricted Location. For the purposes hereof, "Restricted Location" shall include the United States, Malaysia, Ontario (Canada), and such other locations as designated by Blue Whale Finance Operators from time to time as a "Restricted Location" for the purposes hereof; (vi) if you act as an employee or agent of a legal entity, and enter into these Terms on their behalf, you represent and warrant that you have all the necessary rights and authorizations to bind such legal entity and to access and use the Blue Whale Finance Platform and Blue Whale Finance Services on behalf of such legal entity; and (vii) your use of the Blue Whale Finance Platform and the Blue Whale Finance Services will not violate any and all laws and regulations applicable to you or the legal entity on whose behalf you are acting, including but not limited to regulations on antimoney laundering, anti-corruption, and counter-terrorist financing.

### c. User Identity Verification

Your registration of an account with Blue Whale Finance will be deemed your agreement to provide required personal information for identity verification. Such information will be used to verify Users' identity, identify traces of money laundering, terrorist financing, fraud and other financial crimes through Blue Whale Finance, or for other lawful purposes stated by Blue Whale Finance. We will collect, use and share such information in accordance with our Privacy Policy. In addition to providing such information, you agree to allow us to keep a record of that information during the period for which your account is active and within five (5) years after your account is closed, in compliance with global industry standards on data storage. You also authorize us to conduct necessary investigations directly or through a third party to verify your identity or protect you and/or us from financial crimes, such as fraud. The information we require to verify your identity may include, but is not limited to, your name, email address, contact information, phone number, username, government-issued ID, date of birth, and other information collected during account registration. When providing the required information, you confirm it is true and accurate.AFTER REGISTRATION, YOU MUST ENSURE THAT THE INFORMATION IS TRUE, COMPLETE, AND TIMELY UPDATED WHEN CHANGED. IF THERE ARE ANY GROUNDS FOR BELIEVING THAT ANY OF THE INFORMATION YOU PROVIDED IS INCORRECT, FALSE, OUTDATED OR INCOMPLETE, BLUE WHALE FINANCE RESERVES THE RIGHT TO SEND YOU A NOTICE TO DEMAND CORRECTION, DIRECTLY DELETE THE RELEVANT INFORMATION, AND, AS THE CASE MAY BE, TERMINATE ALL OR PART OF BLUE WHALE FINANCE SERVICES WE PROVIDE FOR YOU. ## d. Account Usage Requirements

The Blue Whale Finance Account can only be used by the account registrant. Blue Whale Finance reserves the right to suspend, freeze or cancel the use of Blue Whale Finance Accounts by persons other than account registrant. If you suspect or become aware of any unauthorized use of your username and password, you should notify Blue Whale Finance immediately. Blue Whale Finance assumes no liability for any loss or damage arising from the use of Blue Whale Finance Account by you or any third party with or without your authorization.

## e. Account Security

Blue Whale Finance has been committed to maintaining the security of User entrusted funds, and has implemented industry standard protection for Blue Whale Finance Services. However, the actions of individual Users may pose risks. You shall agree to treat your access credentials (such as username and password) as confidential information, and not to disclose such information to any third party. You also agree to be solely responsible for taking the necessary security measures to protect your Blue Whale Finance Account and personal information.

You should be solely responsible for keeping safe of your Blue Whale Finance Account and password, and be responsible for all the transactions under your Blue Whale Finance Account.Blue Whale Finance assumes no liability for any loss or consequences caused by authorized or unauthorized use of your account credentials, including but not limited to information disclosure, information release, consent or submission of various rules and agreements by clicking on the website, online agreement renewal, etc.

By creating a Blue Whale Finance Account, you hereby agree that:

i you will notify Blue Whale Finance immediately if you are aware of any unauthorized use of your Blue Whale Finance Account and password or any other violation of security rules;

ii you will strictly abide by all mechanisms or procedures of Blue Whale Finance regarding security, authentication, trading, charging, and withdrawal; and

iii you will take appropriate steps to logout from Blue Whale Finance at the end of each visit.

## III. Blue Whale Finance Services

Upon completion of the registration and identity verification for your Blue Whale Finance Account, you may use various Blue Whale Finance Services, including but not limited to, Spot Trading, Fiat Services, contract trading, leveraged trading, Blue Whale Finance Savings services, staking, acquiring market-related data, research and other information released by Blue Whale Finance, participating in User activities held by Blue Whale Finance, etc., in accordance with the provisions of these Terms (including Blue Whale Finance Platform Rules and other individual agreements). Blue Whale Finance has the right to:

- Provide, modify or terminate, in its discretion, any Blue Whale Finance Services; and
- Allow or prohibit some Users' use of any Blue Whale Finance Services in accordance with relevant Blue Whale Finance Platform Rules.

Blue Whale Finance has the exclusive authority to determine which Digital Assets are listed on the platform and may add or remove Digital Assets from the platform in its sole discretion, from time to time. Blue Whale Finance may also change the order size available for each Digital Asset. - 1. Service Usage Guidelines
- a. License

Provided that you constantly comply with the express terms and conditions stated in these Terms, Blue Whale Finance grants you a revocable, limited, royalty-free, non-exclusive, non-transferable, and non-sublicensable license to access and use Blue Whale Finance Services through your computer or Internet compatible devices for your personal/internal purposes. You are prohibited to use Blue Whale Finance Services for resale or commercial purposes, including transactions on behalf of other persons or entities. All the above actions are expressly prohibited and constitute a material violation of these Terms. The content layout, format, function and access rights regarding Blue Whale Finance Services should be stipulated in the discretion of Blue Whale Finance. Blue Whale Finance reserves all rights not expressly granted in these Terms. Therefore, you are hereby prohibited from using Blue Whale Finance Services in any way not expressly authorized by these Terms.

These Terms only grant a limited license to access and use Blue Whale Finance Services. - 1) Trading services that make use of Blue Whale Finance quotes or market bulletin board information.
- 2) Data feeding or streaming services that make use of any market data of Blue Whale Finance.
- 3) Any other websites/apps/services that charge for or otherwise profit from (including through advertising or referral fees) market data obtained from Blue Whale Finance.
- v Without prior written consent from Blue Whale Finance, you may not modify, replicate, duplicate, copy, download, store, further transmit, disseminate, transfer, disassemble, broadcast, publish, remove or alter any copyright statement or label, or license, sub-license, sell, mirror, design, rent, lease, private label, grant security interests in the properties or any part of the properties, or create their derivative works or otherwise take advantage of any part of the properties.
